Senate Bill SB-260 – The Allen Rose Safety Act

Signed into Law

SB 260 allows tow-truck drivers to place a warning sign on the driver's side of unoccupied vehicles scheduled to be towed.

These signs warn drivers that they may be prosecuted for operating or attempting to operate the vehicle being towed.

These signs can only be placed on the vehicle being towed at that time, this is not a license to post multiple signs on multiple vehicles in an effort to keep them hostage until

you return.

Misplacement of a warning sign is a class 3 misdemeanor, which can lead to 0-6 months in jail and/or a fine ranging from \$50 to \$750.¹

Additionally, any attempt to remove warning signs from vehicles by anyone other than authorized tow-truck drivers is a class 3 misdemeanor.

SB 260 also specifies tow trucks as being included in the "Move Over Law".

Senator Morse had this to say ""Towing is a

very dangerous business. This bill seeks to protect tow-truck drivers and make it safer for them to perform their jobs. This bill will help prevent tragedies like this in the future and will make it so that Allen Rose will not have died in vain."

Senate Majority Leader John Morse (D-Colorado Springs) introduced this bill after being contacted by a private citizen, Mike Baier, who wanted to help after seeing what happened to Allen Rose.
